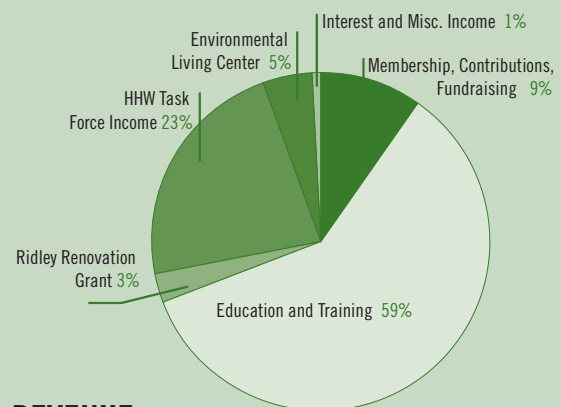

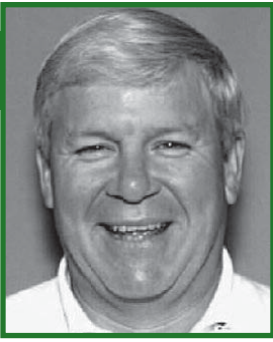

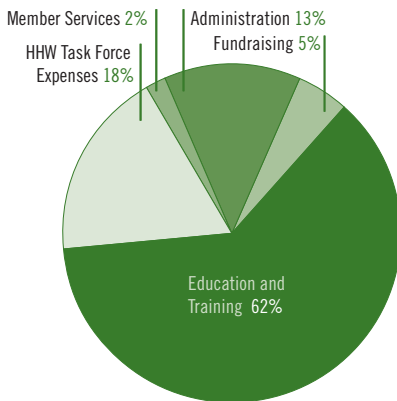

Community Outreach

HAZARDOUS HOUSEHOLD CHEMICAL COLLECTIONS

The Southwest PA Household Hazardous Waste Task Force, administered by PRC, sponsored 7 collections in 6 counties, serving over 3,200 households and collecting more than 265,000 pounds of materials in 2009. Since 2003 the Task Force has sponsored 40 events in 8 counties, served over 21,000 households, and collected nearly two-million pounds of HHW.

HARD-TO-RECYCLE COLLECTIONS FOCUS ON REUSE

The list of materials accepted at the 2009 Hard to Recycle Collection events grew to include items donated for reuse. Two new partners, Global Links (www.globallinks.org) and Construction Junction (www.constructionjunction.org), gave area residents the opportunity to drop off gently used medical equipment and usable building materials at no cost.

FIRST ANNUAL “BOB AWARDS” PRESENTED

In March 2009, the Clean Pittsburgh Commission unveiled its “Bob Awards”, a tribute to the late Mayor Bob O’Connor and his dedication to “Redding Up” the City. Twenty two awards were given to recognize individuals, neighborhoods, college groups, Pittsburgh Public Schools and non-profit organizations whose efforts exemplified those of the late Mayor.

NATURE TRAIL COMES TO LIFE

PRC partnered with the Bethel Springs Elementary School (BSES) Nature Committee to oversee the educational development of the BSES Nature Trail. The trail, located in Delaware County, PA, is a resource for students and community members to learn about wildlife, ecology and environmental stewardship.

PRC’s eastern office assisted municipalities, businesses and residents in 5 counties surrounding Philadelphia with their efforts to control the proliferation of billboards in their communities. Funding from a SAFETEA Grant helped establish a coalition of citizens to coordinate the activities of the group, which included delivering presentations to officials, reviewing ordinances, attending zoning board hearings and the launch of a new website www.nobillboards.com.

Education

ADULT EDUCATION CLASSES CROSS THE STATE LINE

Schrader Environmental Center, Oglebay Resort, West Virginia, was added to the list of venues for PRC's Adult Education Workshops, bringing the total number of classes presented in 2009 to 55. Over 1,200 participants increased their knowledge of watersheds, rain barrels, back yard and worm composting and environmental health at workshops in Pennsylvania and West Virginia.

17 YEARS OF 'STASH THE TRASH'

Since 1992, PRC and the City of Pittsburgh have been the proud sponsors of 'Stash the Trash', a one-day litter pickup that occurs twice a year at schools throughout the city. Over 5,600 students from 48 public, private and parochial schools collected 944 bags of trash and recyclables from their school grounds during the 2009 spring and fall cleanup events.

DON'T FLUSH THOSE PHARMACEUTICALS!

PRC East presented 10 "Medicine Disposal and You!" educational workshops to over 200 senior citizens in Chester and Philadelphia PA in 2009. The

program communicates the "Don't Flush" message and provides information on more environmentally friendly disposal methods. Funding for the program was provided by a grant from Environmental Fund for Pennsylvania.

THE MAGIC OF RECYCLING

Over 6,000 students in grades K through 6 enjoyed PRC's entertaining, educational and fun 'Recycling is Magic' Show and 'Litter and Magic' Show assembly programs during the 2009 school year. Magician Dan Kuniak delighted students as he made glass bottles disappear, created trees out of newspaper & pulled many other tricks out of his bag while teaching the magic words "reduce, reuse, recycle" and "Don't be a Litterbug!"

EITC

PRC's education staff presented 153 environmental education classes to 7,431 school students through Pennsylvania's Educational Improvement Tax Credit (EITC) program. The generous funding of Waste Management, Wawa, PNC Bank and Auqua Pennsylvania made it possible for the students to attend presentations about Litter Prevention, Recycling, Watershed Awareness, Environmental

Business and Collaborations

BATTERY RECYCLING PROGRAM GENERATES A NEW PARTNER

PRC's search for a company that would properly recycle the batteries obtained from the Hard-to-Recycle collections and public drop offs led to the 2009 partnership with Batteries Plus. Not only does Batteries Plus share PRC's passion to keep harmful chemicals out of our soil and water, they recycle all of the batteries in full compliance with federal, state and municipal guidelines.

PRC WINS ONLINE CONTEST

Pittsburgh online clothing retailer ModCloth launched a charity contest in honor of Earth Day 2009. PRC was chosen to compete against three other non-profit organizations to receive 10% of ModCloth's Earth Day sales. An overwhelming number of internet votes deemed PRC the winner! PRC received a very generous donation of unrestricted funds from ModCloth due to the public's overwhelming show of support.

ZERO WASTE PITTSBURGH

PRC's newest project, Zero Waste Pittsburgh (www.zwpg.org), was created in 2009 as a one stop shop for recycling and waste minimization resources and assistance in Southwestern PA for businesses, institutions and special events. The project's efforts focus on recycling, waste minimization, smart product procurement, composting and the sharing of best practices gleaned from practical real world experience.

'LIVING A GREENER LIFESTYLE' WORKSHOPS ENGAGE BUSINESS AUDIENCES

A wide variety of Living a Greener Lifestyle classes were presented by PRC in 2009, each one customized to the type of business of the audience. For

example, the presentation to State Farm employees focused on lifestyle changes they could make to reduce the risk of accidents; while Franklin Mint employees learned how switching to greener products in their homes could save them money.

THE REGIONAL COMPOSTING FRONTIER

PRC presented overviews of the regional composting frontier at a Food Service Industry conference in August, and at a meeting of SW PA County Recycling Coordinators in October.
